I understand and agree that my participation in all activities associated with FORTRESS LAKE RETREAT (the "Activities") is conditional upon my agreeing with the terms contained in this Agreement and my signing this Agreement:

- 1. I am aware and have been fully informed that the Activities involve certain risks, inherent risks, dangers and hazards which can result in serious personal injury or death, including drowning, including, but not limited to risks involving:
  - (a) fishing, riding in boats, canoes, kayaks, sailboats, windsurfing and general transportation by, and use of, watercraft, or being in close proximity to watercraft, which may be operated by myself or by others, including risks of falling from the watercraft, the watercraft failing to operate, the watercraft pitching, tipping, sinking or colliding with other watercraft or obstacles;
  - (b) camping, the out-of-doors, wildlife, rough terrain with obstacles and hazards, extreme or quickly changing weather conditions, including extreme heat or unseasonable cold, flood, lightning, fire, windstorm, or other natural disaster;
  - (c) hiking and circumstances where participants may be lost or separated from the others participating in the Activities;
  - (d) swimming, cold and deep water;
  - (e) physical exertion;
  - (f) circumstances where emergency equipment or arrangements may fail, or fail to be provided in a timely way, or be negligently provided including negligence in the training of emergency procedures or equipment;
  - (g) transportation by motor vehicle, or being in close proximity to motor vehicles, with the risk of motor vehicle accident;

- (h) the conduct of the employees or agents of FORTRESS LAKE RETREAT, and each or any of them, which may be wrong, improper, careless or negligent; or
- (i) other participants in the Activities, who may be inexperienced, negligent, or reckless and may, for other reasons as well, endanger the safety of other participants in the Activities, including myself.
- 2. I accept these risks, dangers and hazards associated with the Activities, and I freely agree to assume all such risks, dangers and hazards and the possibility of personal injury, death, property damage and loss resulting from the Activities.
- 3. I represent to FORTRESS LAKE RETREAT, and each or any of them, that I have the experience required to participate safely in the Activities and that I am not aware of any physical or mental condition which would impair my capability to fully participate in the Activities.
